Event Name: COVID-19

Situation

As of noon today, Sarasota County is reporting 338 confirmed COVID-19 cases, 322 Sarasota County residents and 16 non-Florida residents. There have been 42 deaths reported in Sarasota County to date. Confirmed cases range in age from 0 to 102, with 138 men and 184 women testing positive. There have been 4,489 people tested for COVID-19 with an 8.8 percent positive return rate. All confirmed cases in Sarasota County are receiving the appropriate medical care and are hospitalized or self-isolated.

Sarasota county area hospitals are reporting 50% of intensive care unit (ICU) beds occupied and 59% of all available beds occupied.

The Florida Department of Health is currently reporting a total of 33,193 confirmed COVID-19 cases in Florida.

DOH Sarasota had more than 70 people scheduled for COVID-19 this morning during the by appointment only COVID-19 drive-thru testing at Heron Creek Middle School.

Additional community pop-up testing is scheduled for tomorrow at the Laurel Civic Association, and an additional event was announced for Friday at the Light of the World International Church located at 3809 Chapel Dr, Sarasota.

This community based COVID-19 testing is for anyone who is currently experiencing symptoms (fever, cough, or shortness of breath) or who works in a health care setting. All patients must have an appointment to be tested.

To make an appointment, please call 941-861-2883. Callers will be screened using current CDC testing criteria. Appointments are limited however more testing opportunities may be scheduled in the future.

The Florida Department of Health continues to see new positive cases across the State, please visit www.flhealth.gov/covid-19 for the most current case count and county specific data.

DOH Sarasota is monitoring community health trends on a daily basis to help identify any possible cases of COVID-19. Additionally, the department is serving as an expert resource for health care providers and the public, and working to make sure that health care providers know what to look for and what to do if they suspect COVID-19 in a patient.

DOH continues to visit all licensed long term care facilities in Sarasota County to ensure proper COVID-19 infection control guidelines as established by the CDC are being used to prevent the spread of the virus.

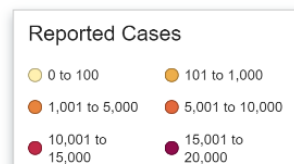
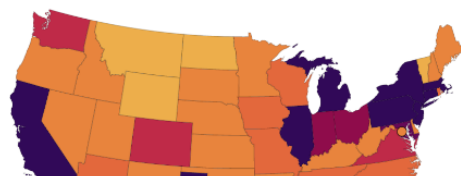
The Florida Department of Health reminds everyone that the elderly and those with underlying medical problems like high blood pressure, heart problems and diabetes are more likely to develop serious illness.

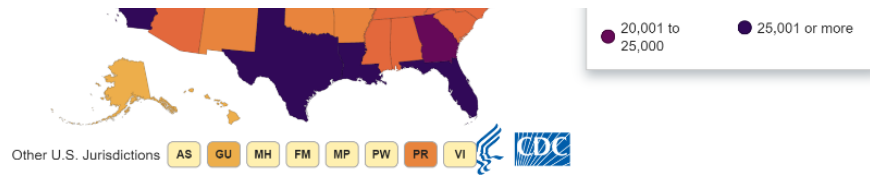
If you are sick with COVID-19 or suspect you are infected with the virus that causes COVID-19, follow the steps below to help prevent the disease from spreading to people in your home and community.

18 states report more than 10,000 cases of COVID-19.

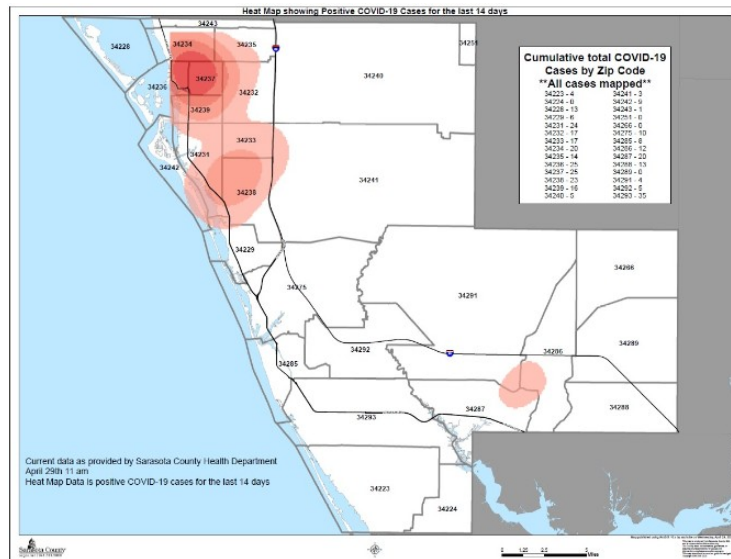

Possible Impacts

COVID-19 is a new disease and there is limited information regarding risk factors for severe disease. Based on currently available information and clinical expertise, older adults and people of any age who have serious underlying medical conditions might be at higher risk for severe illness from COVID-19. More cases of COVID-19 are likely to be identified in the coming days, including more cases in the United States. It's also likely that person-to-person spread will continue to occur, including in communities in the United States. It's likely that at some point, widespread transmission of COVID-19 in the United States will occur.

Timing

Symptoms may be mild to severe and may appear 2-14 days after exposure.

Watch, Warnings, Advisories

Global Level 4 Health Advisory - Do not travel.
Public Health Advisory for Vulnerable Populations, Gatherings of Private Citizens and Density of the Workforce.

Global Level 4 Health Advisory

The Department of State has issued a Global Level 4 Health Advisory, advises U.S. citizens to avoid all international travel due to the global impact of COVID-19.

Travel in the United States

Cruise Ship Travel

The CDC urges residents of New York, New Jersey, and Connecticut to refrain from non-essential domestic travel for 14 days effective immediately. This Domestic Travel Advisory does not apply to employees of critical infrastructure industries, including but not limited to trucking, public health professionals, financial services, and food supply.

CDC has issued a Level 3 Travel Health Warning for cruise ship travel. CDC recommends that all people defer travel on cruise ships, including river cruises, worldwide. That's because the risk of COVID-19 on cruise ships is high. Older adults and people with serious chronic medical conditions, such as heart disease, diabetes, or lung disease, should especially defer travel on cruise ships, including river cruises, because of their increased risk for severe disease.

Passengers who return from a cruise ship or river cruise voyage are advised to stay home for 14 days, monitor their health, and practice social distancing.

Sarasota County Actions

Sarasota County canceled all events, reservations and registrations at county facilities through May 17.

Effective April 30 curbside permitting services will be offered at both 1001 Sarasota Center Blvd., Sarasota and 4000 S. Tamiami Trail, Venice.

Health and Human Services opened a mobile testing site at Heron Creek Middle School by appointment only for April 29.

Utilities fees and service shutoffs are suspended through May 31.

Beaches open for limited use and essential activities only, effective April 27.

Receiving and distribution of state supplies is ongoing.

The County Administrator extended the emergency declaration through May 1, 2020. The EOC will continue to monitor this dynamic situation and support government operations and partners to ensure resources are available when needed. If you are assigned to the EOC or are called to report, you will receive a health screening before entering the building. Please remember to complete a Daily Disaster Logs and follow submission instructions from your Disaster Log representative.

Developed internal process for loan approval and payment of Small Business Loan Program.

Federal VA team is in Sarasota to augment patient care in the long term care facilities while concurrently providing on the job training and coaching on improved infection control practices and proper use of PPE.

Received full approval from the state for a non-congregate shelter plan for first responders.

SCAT has suspended service of Routes 4, 11, and 18 and has began On Demand Services for public transportation for essential trips such as employment, medical appointments, pharmacy and grocery shopping.

Employee Health and Benefits announced Virtual EAP sessions to help employees cope with stress.

All visitations at Admin. and BOB are by appointment only. Visitor prescreenings are being conducted prior to entrance.

Key Points

CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies) especially in areas of significant community-based transmission.

There is currently no vaccine to prevent COVID-19. The best way to prevent illness is to avoid being exposed to this virus. As a reminder, the Department always recommends everyday preventive actions to help impede the spread of respiratory diseases, including:

Avoiding close contact with people who are sick

Staying home when you are sick and avoiding contact with persons in poor health;

Avoiding touching your eyes, nose and mouth with unwashed hands;

Covering your cough or sneeze with a tissue, then disposing of the tissue;

Washing your hands often with soap and water for at least 20 seconds, especially after going to the bathroom, before eating, after blowing your nose, coughing or sneezing; - If soap and water are not readily available, use an alcohol-based hand sanitizer with at least 60% alcohol. Always wash hands with soap and water if hands are visibly dirty;

Cleaning and disinfecting frequently touched objects and surfaces using a regular household cleaning spray or wipe.

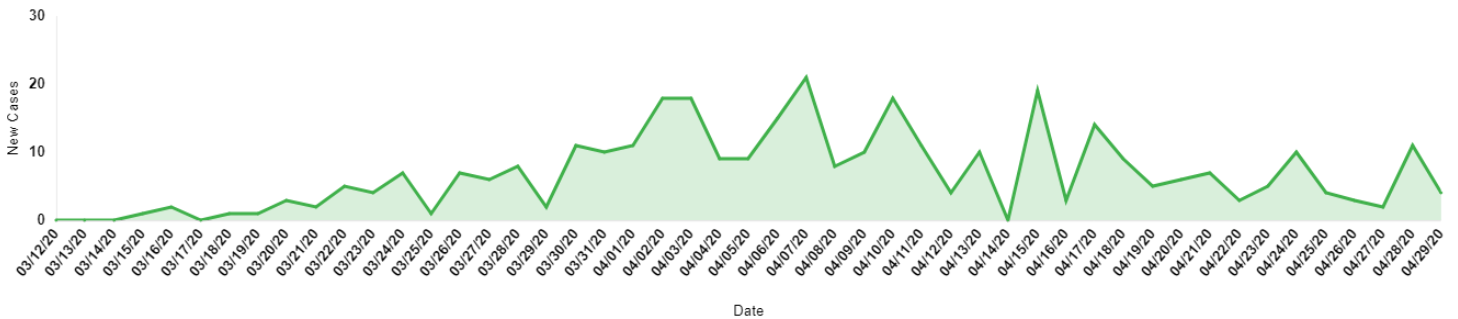

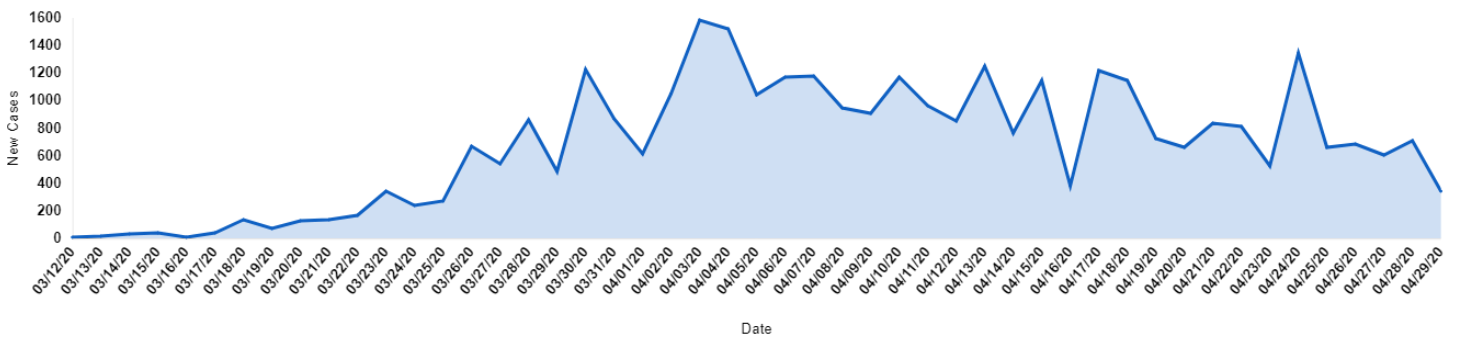

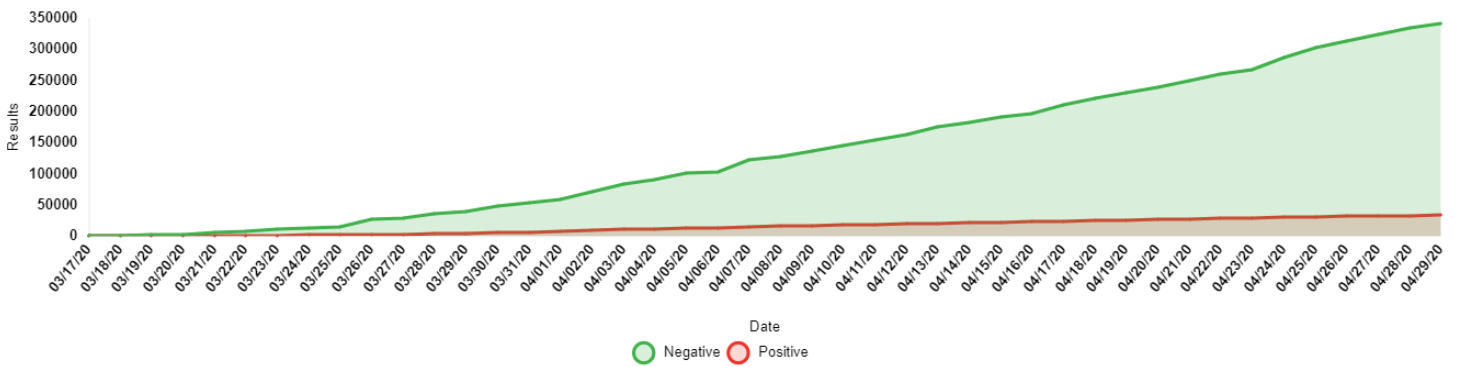
New Cases in Sarasota



New Cases in State of Florida



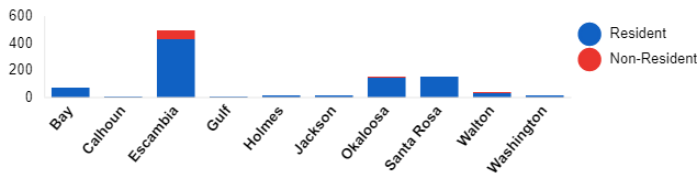
Negative vs. Positive Results in State of Florida



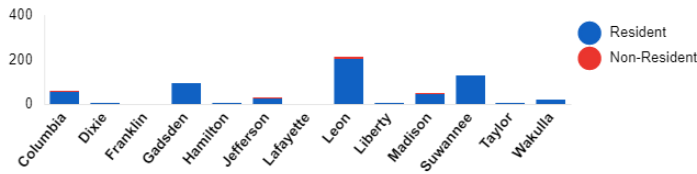

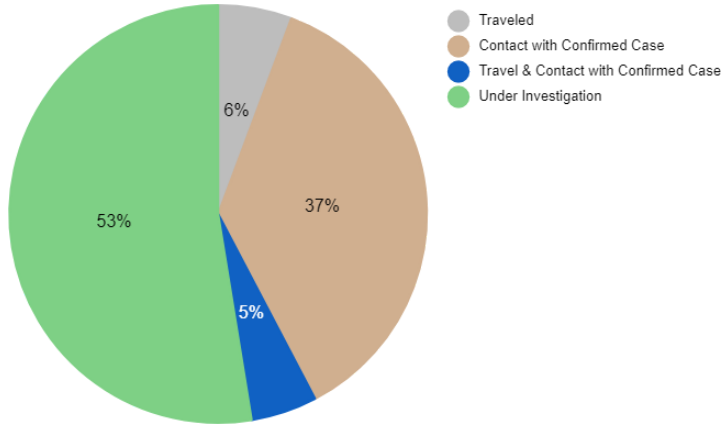

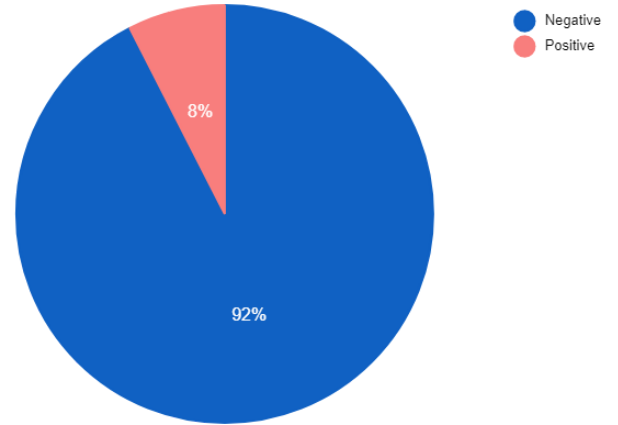
